## **Policy Statement**

- o Include anti-slavery clauses in all contracts with suppliers and contractors.

#### 3. Training and Awareness

- Provide training for all employees, especially those in procurement, HR, and site management, on the risks of modern slavery and how to identify and report potential issues.
- Raise awareness among staff and contractors through regular communications and updates on the importance of combating modern slavery.

## 4. Reporting and Whistleblowing

 Establish a confidential reporting mechanism for employees and contractors to report concerns about modern slavery or human trafficking.
